


1. The Items rate to be quoted by the agency as per attached DNIT conditional tender will not be accepted.
2. The quotation may be sent in favour of the Registrar, BPSMV Khanpur Kalan in sealed envelope by registered post / by hand before time.
3. In case the day of opening of bid happens to be holiday the tender quotations will be opened on the next working day. The time and place of receipt of bid and other condition will remain unchanged.
4. The tender quotation should be submitted on printed letter head along with their above documents must accompany with self attested copy with respective rubber seal.
5. The work shall be executed within the time limit i.e. one month.
6. All the charges including packing, transporting, taxes, delivering at site for and other levies should be included in rates. The charges if specified separately in the limited tender shall not be paid.
7. All disputes shall be subject to Sonipat jurisdiction.
8. The agency will be responsible for any defect till the item is carried under guarantee / warranty specified by manufactures.
9. University / Engineer – In-Charge is competent to increase / decrease the quantity of work as per site requirement.
10. Central / State taxes G.S.T will be applicable as per Govt. / University rule for supply of material.
11. University / Engineer-in-charge shall have the right to make any amendment which in his opinion may be necessary during the progress of execution of the work, such amendment shall in no way, invalidate the contract and material will be got inspected before installation by Engineer-in-charge.
12. Work / material shall be executed / supplied as per P.W.D / U.H.B.V.N specification and in good conditions by the agency.
